A note to follow up on the proposed Wayne Bunker pickleball project.

Key leadership and sources associated with Southern Nevada Pickleball (SNP); a local 501(c)(3) organization, have reviewed the revised drawings.

Based on observation and our experience, we would like to add feedback to improve upon the project.

1. Add more parking. Considering recreational play; pickleball attracts an average

- 1.2 players per vehicle, the courts fill up with player-queuing beginning 1 hour into prime time and the average core player is at the venue 2.5 hours. Given this customary utilization pattern, the numbers don't add up for the available parking. Current parking will not accommodate a tournament.
2. Can additional shade be added? Given outdoor play and the Las Vegas heat, people play early morning or in the evenings to escape the sun. What can be done to encourage use of courts midday?
3. Does lighting compare to or better that of Sunset Park? Lighting is important for evening play. What type of photometrics are available?
4. Based on our experience conducting regional and local tournaments, we would like to make certain that infrastructure accommodates events: i.e. operations office for tournament desk, accommodation for sound/speaker system for announcements, internet/WIFI, a place to post information and power outlets near courts.
5. In terms of landscaping and ground cover, please avoid trees/shrubs nearby that shed on the courts and dirt/small decorative gravel that end up on courts. We do realize that proper tree placement is needed to control wind and mitigate sound.

Southern Nevada Pickleball, Inc. has the expertise to add value to this project and for consultation.

We commend the City of Las Vegas for taking action and making this recreation opportunity possible.
