**** STAFF REPORT ****

PROJECT DESCRIPTION

The applicant is requesting an Extension of Time for a Temporary School Campus located at the northeast corner of St. Louis Avenue and Atlantic Street.

ISSUES

- Special Use Permit (20-0278-SUP1) for an Alternative Parking Standard approved on 02/09/21 in conjunction with Site Development Plan Review (20-0278-SDR1) was exercised on 09/10/21 with the issuance of a building permit (L21-00301) for the Temporary School Campus and an Extension of Time for the Special Use Permit is not required.
- Condition of Approval number two (2) of Site Development Plan Review (20-0278-SDR1) states, “this approval shall be void three years from the date of final approval, and the modular are to be removed unless an Extension of Time is approved by the City Council.” The applicant is requesting a three-year Extension of Time, which staff supports.

ANALYSIS

The subject site is a Clark County School District campus that was originally constructed in 1959, with the school building being demolished in 2020. The site is now home to a Temporary School Campus consisting of portable classrooms that is utilized by the Clark County school District (CCSD) to house students displaced from other campuses that are undergoing renovations and/or redevelopment. The Temporary Campus includes 36 classroom portables, two administrative portables, and six restroom portables. All portables are single-story and utilize the existing play areas and parking lot that were left intact from the original school campus that was demolished in 2020.

On February 22, 2024 at approximately 8:00 a.m. staff performed a routine field check while school was in session. Staff observed multiple parking lot areas with available parking stalls, as well minimal street parking. The campus was secure with a chain link fence and vehicular gates at driveways, typical of Clark County School District campuses around the City. Staff observed the campus operating with no negative impact to the surrounding residential neighborhood. Therefore, staff is recommending approval of this request with conditions.

FINDINGS (24-0048-EOT2)

Staff finds the temporary use continues to be conducted in a manner that is harmonious and compatible with the surrounding residential neighborhood as the site will continue to operate as an educational campus for students temporarily displaced due to construction of their respective school campuses. As requested by the applicant, staff has placed a three-year time limit to the requested Extension of Time, and is recommending approval of the request.
