The 1970's era apartment buildings are old and blighted. This exterior remodel will include the removal of the current landscaping and replace it with artificial grass, pavers, planters and a dog area in the back area of the buildings. The exterior remodel will include the installation of new double insulated doors and windows along with stucco repair, brick veneer, new railings and a full repainting of the buildings. The project will employ at least 4 FTEs.

The MFRVIP funds will be used to assist with renovating the exteriors of the buildings and surrounding landscape areas. The owner is also be conducting a full remodel of the 16 apartment unit interiors and has also applied for a MFRUIP in tandem with this MFRVIP.

Approximately \$213,909., in exterior improvements are planned and will be paid for by KLA Capital Series, LLC, the Owner.
