

**SUPPLEMENTAL INTERLOCAL CONTRACT NO. 2
CITY OF LAS VEGAS NON-PROJECT SPECIFIC FISCAL YEAR 2022-2026**

THIS SUPPLEMENTAL INTERLOCAL CONTRACT NO. 2 is made and entered into this 14TH day of November 2024, by and between the City of Las Vegas, a municipal corporation, hereinafter referred to as “CITY” and the Regional Transportation Commission of Southern Nevada, hereinafter referred to as “RTC.” The CITY and RTC are collectively referred as the “PARTIES.”

W I T N E S S E T H

WHEREAS, the RTC approved Interlocal Contract 1291 dated July 8, 2021, and supplemental interlocal contract dated July 14, 2022, for City of Las Vegas Non-Project Specific Fiscal Year 2022-2026, hereinafter referred to as “PROJECT,” located wholly within City of Las Vegas; and

WHEREAS, a contract to enable the CITY to be reimbursed the cost of work related to RTC issues that are not attributable to a specific project has been approved; and

WHEREAS, it is desired that the CITY utilize this reimbursement to expedite RTC roadway projects; and

WHEREAS, Nevada Revised Statutes (NRS) Chapter 277.180 authorizes any one or more public agencies to contract with any one or more other public agencies to perform any governmental services, activity or undertaking which any of the public agencies entering into the agreement is authorized by law to perform and refers to such as an interlocal contract; and

WHEREAS, the CITY agrees to conform to the current RTC Policies and Procedures, as amended and incorporated herein by reference; and

WHEREAS, the CITY wishes to increase total PROJECT funding; and

NOW, THEREFORE, in consideration of the covenants, conditions, agreements, and promises of the PARTIES hereto, the PARTIES agree to proceed as follows:

SECTION II: PROJECT COSTS; Paragraphs 1 and 2 shall be revised to read as follows:

1. The total cost for this contract shall not exceed \$800,000.00
2. Authorizations to Proceed (ATP) are granted as follows:
 - a. ENGINEERING not to exceed \$800,000.00
 - b. RIGHT-OF-WAY not to exceed \$0.00
 - c. CONSTRUCTION not to exceed \$0.00

The remainder of Interlocal Contract No. 1291 dated July 8, 2021 and supplemental interlocal contract dated July 14, 2022, shall remain unchanged.
