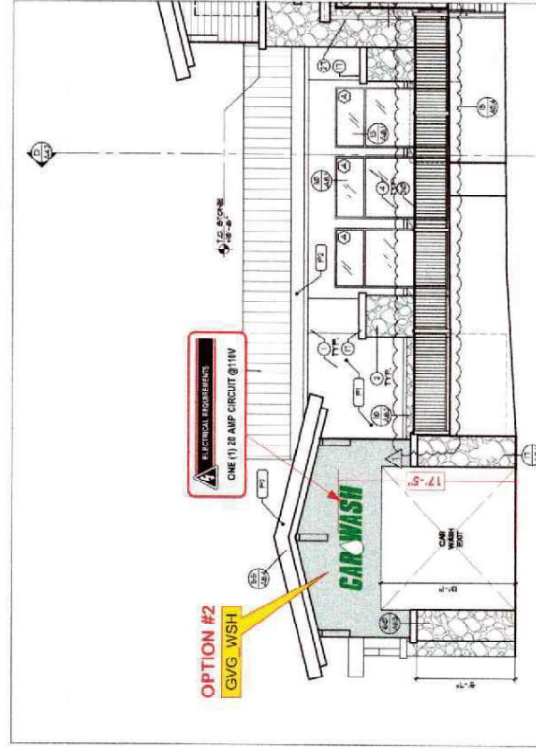

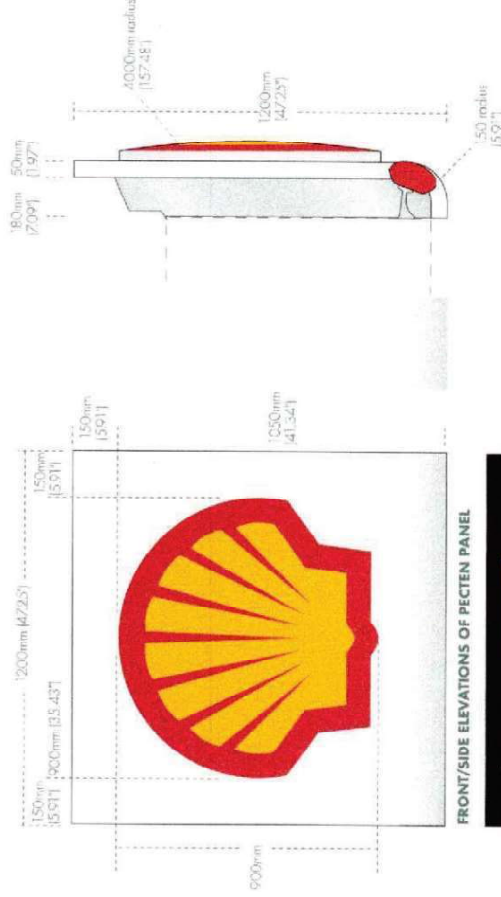
## 2.2.2 PECTEN PANEL

### THE SHELL PECTEN PANEL

#### Iconic recognition

The internally illuminated canopy edge Pecten panel provides iconic brand recognition. Constructed from a one-piece moulding with a gentle curve to its face the Pecten projects slightly from the white backing panel so that at night a gentle halo glow is achieved. Note that the white panel itself is not illuminated.

As with other forecourt elements, the Pecten panel has a curved edge that links with the adjacent canopy fascia. Finished in Shell White the slim profile panel fixes back to the canopy's edge.

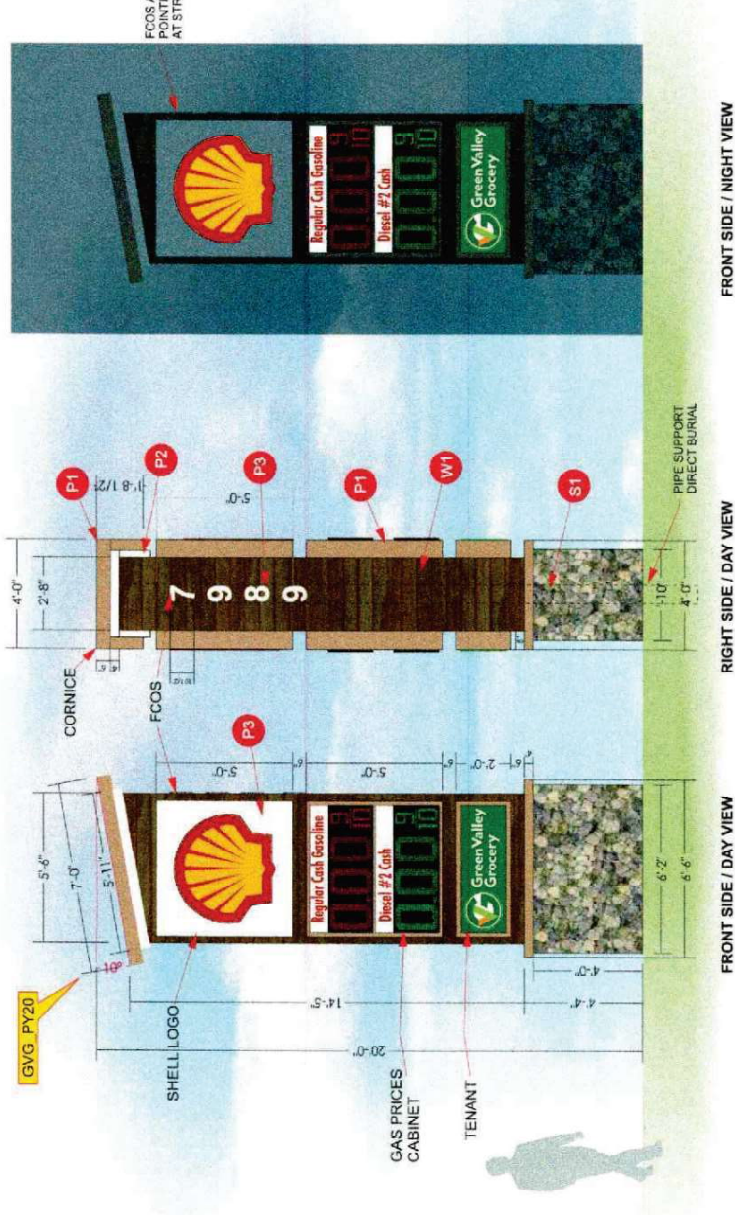

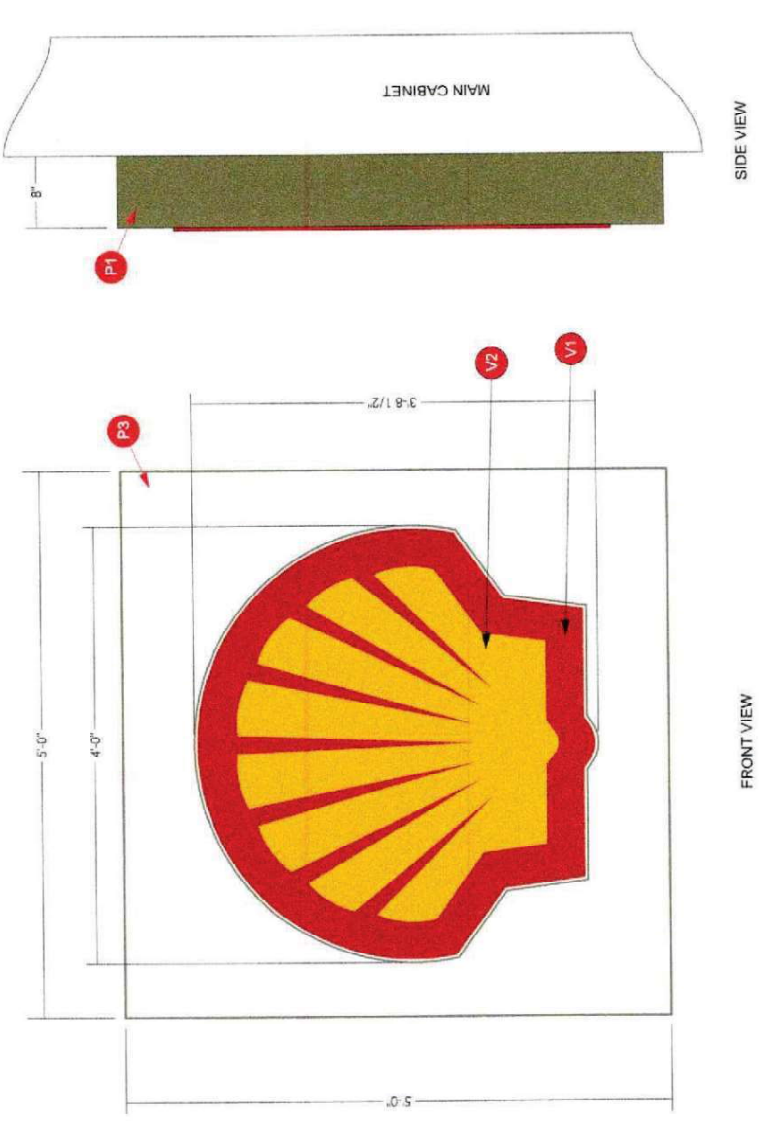
