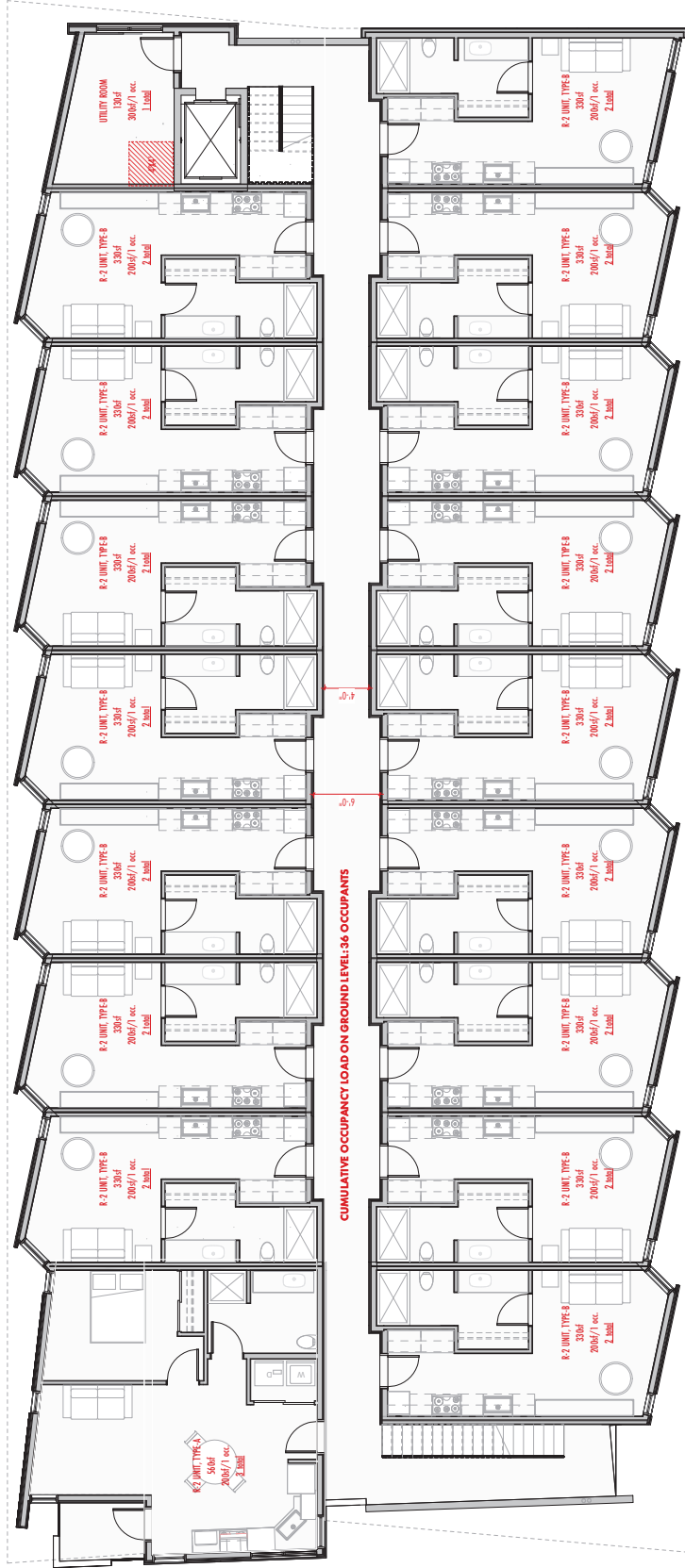

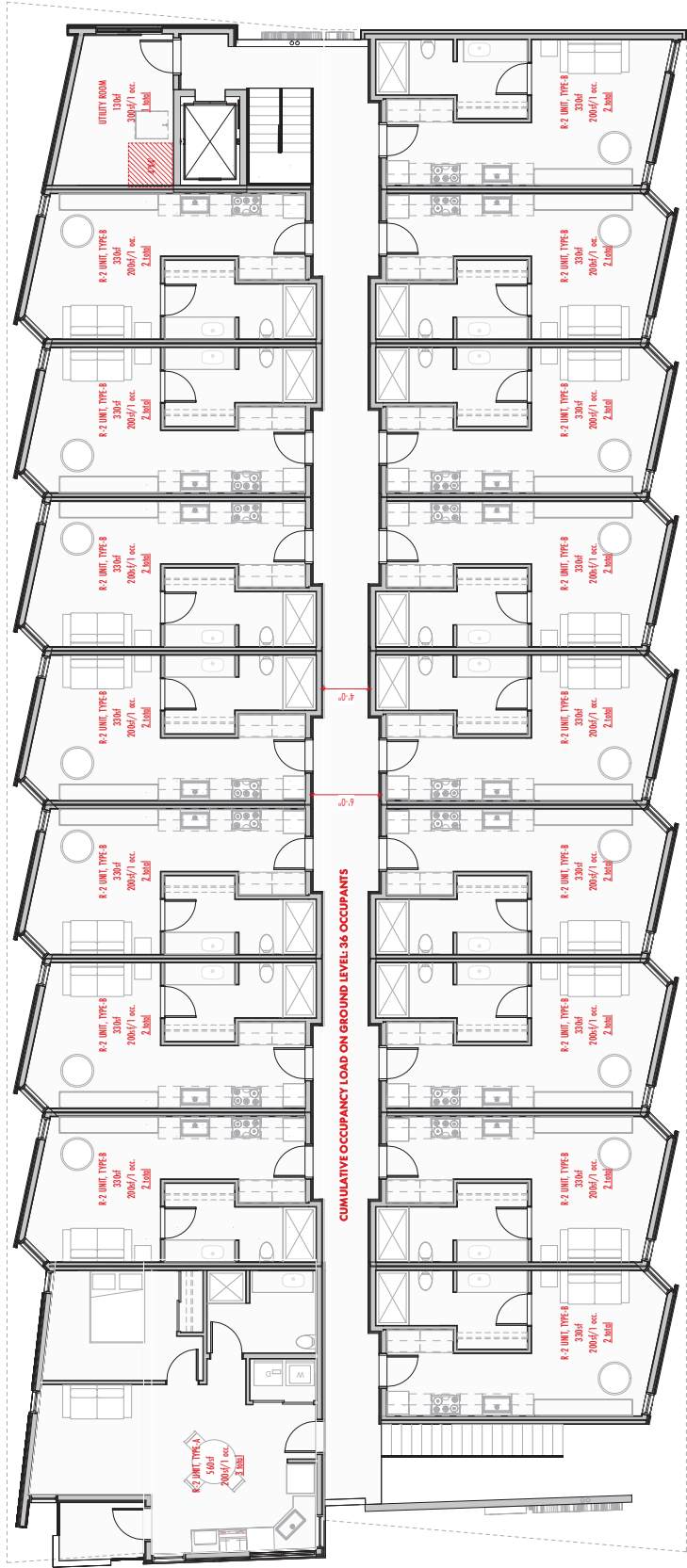

Level 2 Floor Plan



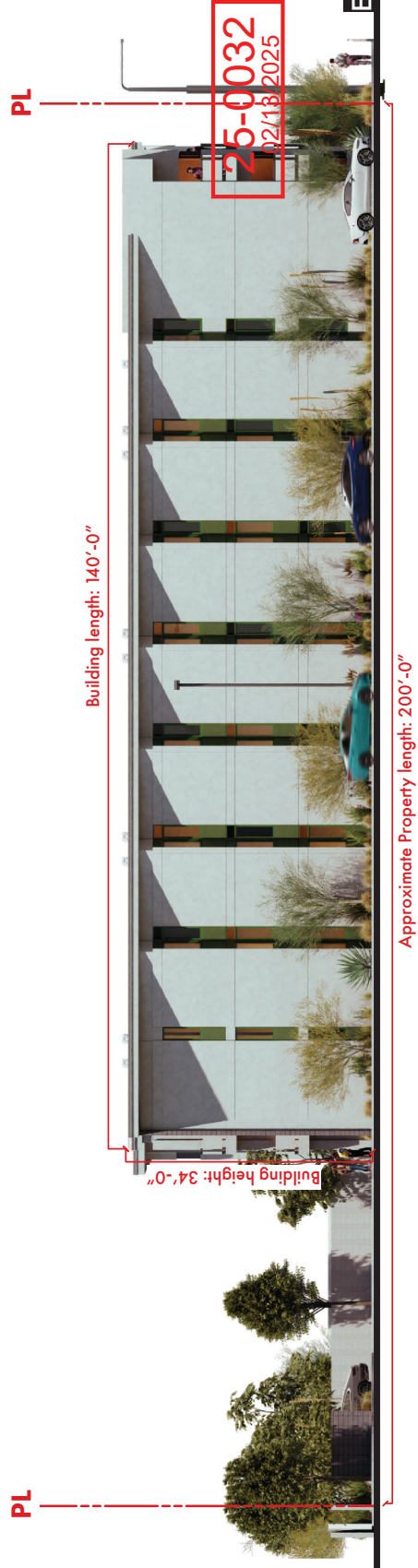

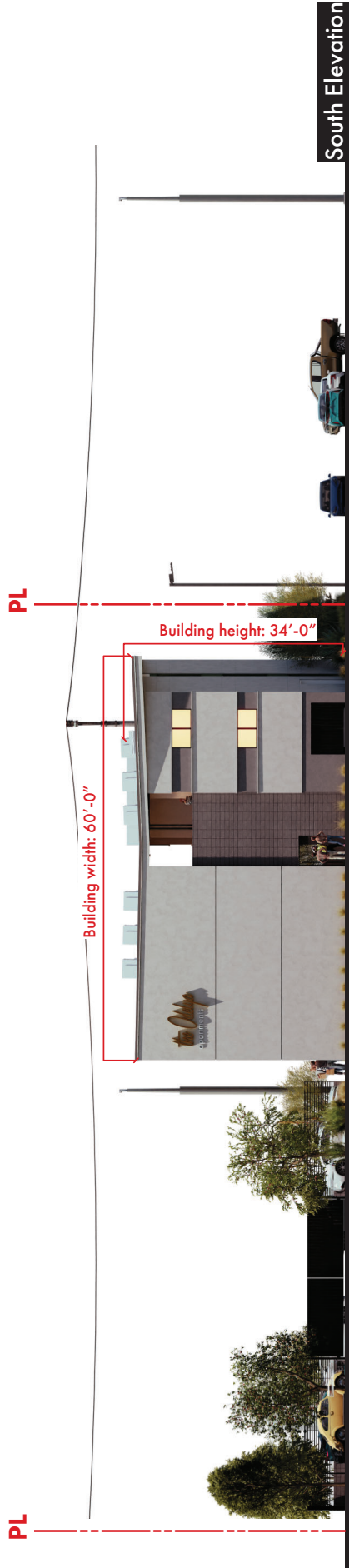

Level 3 Floor Plan



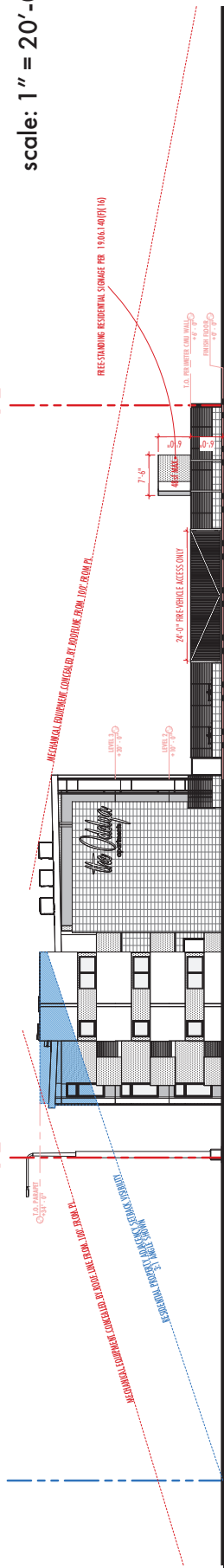

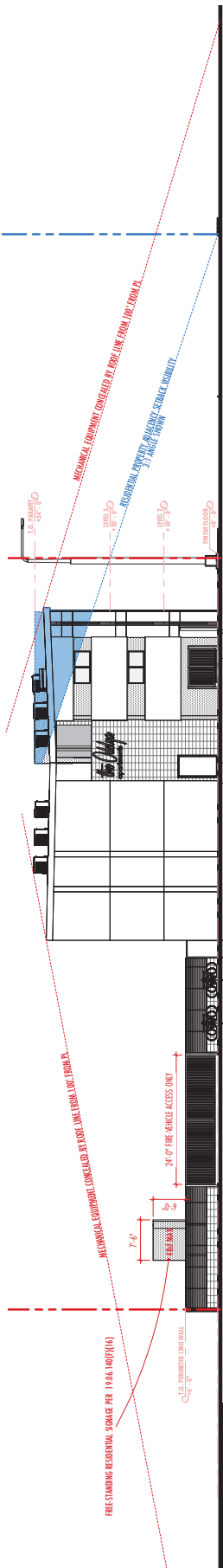

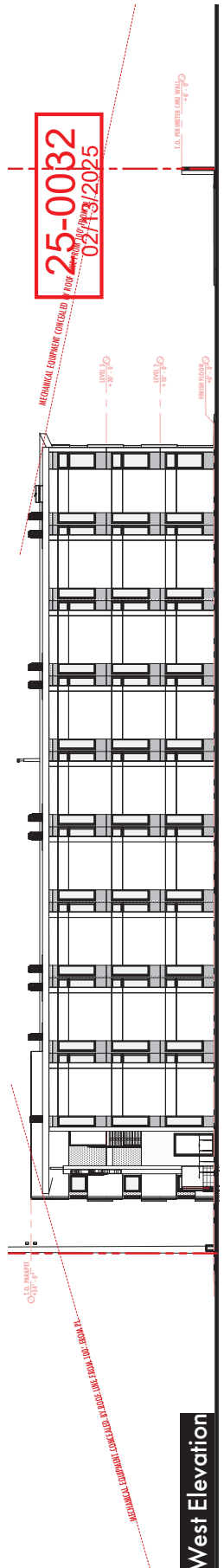

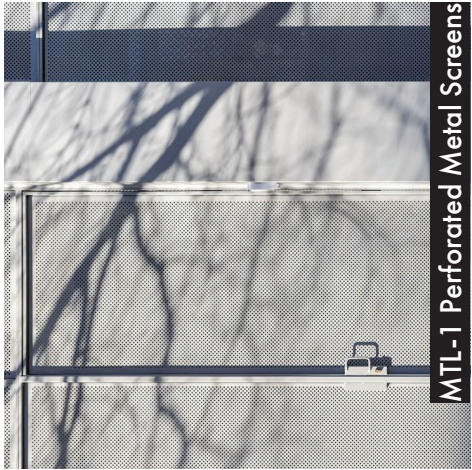
