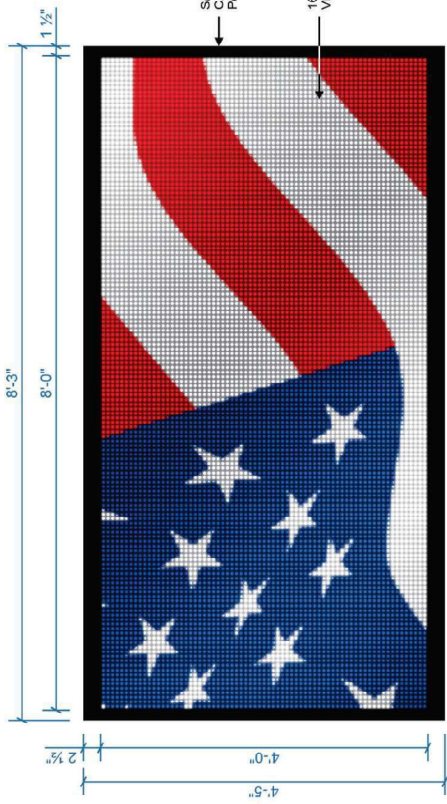
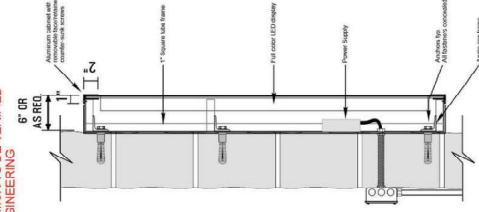

- MANUFACTURE & INSTALL ONE (1) NEW S/F 4'-5" X 8'-3" WALL MOUNTED SIGN W/ FULL COLOR 16MM LED MESSAGE UNIT. AUTO-DIMMABLE TO COMPLY WITH LOCAL ORDINANCES. BRIGHTNESS NOT TO EXCEED 0.3 FOOT-CANDELES AT NIGHT.
