**** STAFF REPORT ****

PROJECT DESCRIPTION

Pursuant to Ordinance 6788 and Nevada Revised Statutes NRS 278.190, the Planning Commission is required to review the plan and its implementation progress annually. The attached annual report (Exhibit A) is the third given on the implementation of the City of Las Vegas 2050 Master Plan since its adoption in July 2021. Overall, the Las Vegas 2050 Master Plan is in compliance with Nevada Revised Statutes (NRS) and all required components of the plan have been addressed. Twenty-six of the top “Fifty by ‘50” Master Plan outcomes have positive performance or improving trends from baseline. Additional implementation recommendations are indicated for the upcoming year.

ANALYSIS

The annual report on master plan implementation required by NRS 278.190 and by ordinance provides both the Planning Commission and City Council an opportunity to review the progress of the plan over time, as well as provide recommendations on further implementation over the course of the next year. On July 21, 2021, the City Council adopted the City of Las Vegas 2050 as the new long-range comprehensive master plan for the City of Las Vegas (Ordinance 6788). Several sections of the ordinance, as well as Chapter 5 – Implementation, direct planning staff to provide a general annual review and evaluation of the plan and make any necessary updates.

With respect to the plan’s structure, the 2050 Master Plan addresses a comprehensive range of elements required by NRS 278.160. For each topic, goals, key actions and implementation strategies, and outcomes address short and long-term opportunities and challenges:

- Goals are statements that identify a desired long-term objective to be realized related to a theme or topic. Each are supported by the plan’s guiding principles of equity, health, resilience, livability, and innovation. Goal achievement is realized long-term based on the performance of Key Actions and Outcomes.
- Key Actions and supporting implementation strategies are necessary steps that the City, department, external agency, or collaborator can perform within a timeframe to put plan recommendations into effect. Each action can be classified as one or more specific “Tools” - best practices, approaches, and recommendations.

- Outcomes are specific measurable targets connected to metrics or other objective criteria. Outcomes and metrics, were derived or adapted from the City's LEED for Cities Gold certification by the US Green Building Council or from other parallel planning efforts, such as the Vision 2045 Downtown Las Vegas Masterplan or other special area plans.

Contained within the plan are “Fifty by ‘50” outcomes – a collection of outcomes with elevated importance and that largely serve as the basis for determining achievement of the plan’s goals. Many of these outcomes contain long-term trend-based metrics that can be tracked to show progression throughout the plan’s thirty year horizon. To assess each, a plan implementation evaluation methodology was internally developed for all qualitative and quantitative outcomes of the plan (Exhibit B).

To implement various components of the 2050 Master Plan, tools were recommended for each of the Key Actions, which may be implemented short-term, long-term, or on an ongoing basis by City departments, external stakeholders, or community groups. These tools include:

- Local policy or regulation: actions taken by the City Council or Planning Commission by ordinance, resolution, or action by the City Manager or through the City’s departments.
- City Programs: carrying out new or existing City programs, whether delegated from the Plan, the City’s Strategic Plan, through the City Manager, or NRS.
- Capital Improvements: development, provision, and maintenance of physical infrastructure, recommended through the annual Capital Improvement Planning process.
- Federal/State Legislative policy: due in part to the limitations of limited functional home-rule, supportive changes to NRS or to the City’s Charter may be needed to implement components of the plan and must be advocated for in Carson City during a legislative session. Similarly, Federal tools and resources can assist the City through one-time projects or ongoing support of required programs or service provision.
- Partnerships: Implementation through collaborative efforts with regional partners or agencies.

To support incremental implementation of the City’s Master Plan, strategic plans, including current 2020 Citywide Strategic Plan, incorporates City Council priorities. During this cycle, the previous plan included a focus on public safety, health care, and economic diversification. As new Council members are seated during future election cycles and as Council priorities change, future strategic plans can build from the Master Plan’s recommended key actions and implementation strategies in a manner in order to achieve the City’s stated outcomes.
