

**SUPPLEMENTAL INTERLOCAL CONTRACT NO. 4
ARTERIAL RECONSTRUCTION – GOMER ROAD, GOWAN ROAD,
DURANGO DRIVE, EASTERN AVENUE, AND VARIOUS ROADWAYS**

THIS SUPPLEMENTAL INTERLOCAL CONTRACT NO. 4 is made and entered into this 9TH day of November 2023, by and between Clark County, a political subdivision; and the City of Las Vegas, a municipal corporation; and the City of Henderson, a municipal corporation; hereinafter referred to individually as “ENTITY” or collectively as “ENTITIES,” and the Regional Transportation Commission of Southern Nevada, hereinafter referred to as “RTC.” The RTC and the ENTITIES are hereinafter referred to individually as “PARTY” or collectively as “PARTIES.”

WITNESSETH;

WHEREAS, the RTC approved Interlocal Contract 3009 dated February 10, 2022, and supplemental interlocal contracts dated May 19, 2022, November 10, 2022, and September 14, 2023, for Arterial Reconstruction – Gomer Road, Gowan Road, Durango Drive, Eastern Avenue, and Various Roadways, hereinafter referred to as “PROJECT,” located wholly within Clark County, Nevada; and

WHEREAS, Nevada Revised Statutes (NRS) Chapter 277.180 authorizes any one or more public agencies to contract with any one or more other public agencies to perform any governmental services, activity or undertaking which any of the public agencies entering into the agreement is authorized by law to perform and refers to such as an interlocal contract; and

WHEREAS, the ENTITIES agree to conform to the current RTC Policies and Procedures, as amended and incorporated herein by reference; and

WHEREAS, the ENTITIES desire to add the City of Las Vegas, a municipal corporation; and the City of Henderson, a municipal corporation; to Interlocal Contract 3009 to provide financial assistance on the PROJECT; and

NOW, THEREFORE, in consideration of the covenants, conditions, agreements, and promises of the PARTIES hereto, the PARTIES agree to proceed as follows:

SECTION III: GENERAL; shall be revised to include Paragraph 9 as follows:

9. The COUNTY will be the lead agency for the PROJECT with the City of Las Vegas and City of Henderson providing financial assistance; and

The remainder of Interlocal Contract 3009 dated February 10, 2022, and supplemental interlocal contracts dated May 19, 2022, November 10, 2022, and September 14, 2023, shall remain unchanged.
