<b>AUTHORITY:</b>	Consolidated Library District created by the 1985 Legislature S. B. 158, 2-18-85 NRS 379.0222 Amended per Bill 2001-70, Ordinance 5346, adopted 8-1-2001 regarding Financial Disclosure requirement Per L.V.M.C. 2.49.010, a person is not eligible to serve on this board unless he or she is a resident of the City of Las Vegas.	
<b>TERM:</b>	4 years (limited to 2 terms*) (Must fill unexpired portion of terms, if appropriate) *In March of 2009, the Consolidated Library District Attorney reversed the opinion made in 2003 that members may serve two four-year terms plus any unexpired portion of a term to which they have been appointed, provided the total number of years does not exceed 10 years. The new opinion removes the 10 year cap while maintaining the limit to two full terms in addition to any portion of an unexpired term to which the member has been appointed.	
<b>MEMBERS:</b>	5 members appointed by the City Council (County also appoints 5 members)	
<b>NOTES:</b>	<b>MUST BE CITY OF LAS VEGAS RESIDENT</b>  Per Senate Bill 147, effective June 11, 2003, compensated boards meeting certain criteria are no longer required to file State Financial Disclosure Statements. This board meets that established criteria.  Members receive \$40 per meeting, but not more than \$80 per month.
