Re: Appeal of Planning Commission Decision of December 12,  
2023; Item 23-0382-SDR1

To Whom It May Concern:

On December 12, 2023, the Planning Commission heard the application of the City of Las Vegas regarding the pickleball courts at Bunker Park. The Item number was 23-0382-SDR1. They resolved to Approve Items 22a and 22b subject to condition(s) and adding the following conditions as read for the record:

A. An administrative required review shall be performed six months after completion of the park expansion and operation commences of the pickle ball courts.

B. A sound study shall be performed prior to the issuance of a building permit.

C. No parking signs shall be installed along Constantinople Avenue adjacent to the park

As one of the residents most impacted by the proposed pickleball courts, I am appealing the decision in that it is not sufficiently specific and contains meaningless requirements.

First, conducting an administrative review after completion of the park ignores the problems. If the review is conducted after the park is completed, then there is no opportunity to correct any problems which may arise from the design of the park. Moreover, an administrative only review without the opportunity for public input precludes the planning commission from obtaining information which may be relevant to the review.

Second, the requirement of a sound study without criteria means a haphazard study can be conducted without regard to the actual results of the study. For example, if the study finds that the noise level created by the courts at average usage is

equivalent to the noise of a freeway, regardless of the impact of this level of noise on the health and quality of life of the local residents, the building permit would issue. However, if a criteria for the sound study is established, then the study becomes a valid measure instead of a perfunctory, uninformative, low threshold.

It is important to note that other jurisdictions have reviewed the issue of noise generated by pickleball courts. Articles discussing various determinations in other jurisdictions include:

The plethora of litigation from not only across the country, but also from Canada provides a significant reason why this project should be deemed fatally flawed.

Third, while I agree with the requirement of posting No Parking signs based on promises previously made, the signs will be ignored as long as there is a gate on the east end of the complex. An example of this is the No Parking signs on Prairie Falcon adjacent to the post office on N. Tenaya. After 5 pm, people going to the sports businesses on the north side of the street park on the street despite the No Parking signs. At the initial neighborhood meeting, a representative of one of the pickleball associations stated that over 1000 people show up for tournaments at Sunset Park. No Parking signs will be meaningless with crowds



of that size.

There are three additional issues which were not addressed by the Planning Commission although raised by residents. First, the lack of a solid wall between the pickleball courts and the church will lead to disruptions of the regular services held at the church. Second, no response was provided to the concern that the placement of bathrooms and other water uses may be deemed by the State Engineer to be too close to the community well that services our properties. If it is too close, and that is subject to the State Engineer's discretion, we can be forced to go off our well and onto the water district's system. The cost of this could be in excess of \$100,000 per home. This significant financial impact has not been addressed. Third, a request for a drainage study, particularly given that the significant rain in September caused damage to the dirt between the end of the paved portion of Constantinople and the perimeter track of the detention basin.

While I appreciate the additional requirements, they are too vague to be enforceable or to have a meaningful impact on the burdens placed on the neighborhood. To reiterate a position I have stated on the record before, I oppose this proposed development and believe the City acted in an arbitrary and capricious manner without regard to the immediate neighbors' well being and quality of life.
