Chief,

The current **Control Center Supervisor** eligible list was certified on 2/12/25 and is set to expire on 8/12/25. We received 65 applications during the recruitment, with only 11 of those meeting the minimum qualifications.

Of the 11 invited to test, 3 withdrew and 1 was a no show. Of the remaining candidates, 5 placed in Group 1 and moved forward to backgrounds. All 5 were heard at the hiring meeting on 3/26/25.

No selection was made from that meeting. To move forward with a new recruitment, you would need to request abolishment of the current list, based on the information presented above.
