- CATEGORY A**    **SMALL BUSINESS OWNER** whose business address is located within the Redevelopment Area.
- CATEGORY B**    **LICENSED REAL ESTATE PROFESSIONAL** which may include a real estate attorney or realtor who is active in real estate transactions, financing, or analysis and whose business address is located within the City of Las Vegas.
- CATEGORY C**    **DEVELOPMENT COMMUNITY MEMBER** which may include architect, developer, or contractor whose business address is located within the City of Las Vegas.
- CATEGORY D**    **RESIDENT HOMEOWNER OF A SINGLE FAMILY HOME** located within the Redevelopment Area.
- CATEGORY E**    **APARTMENT RENTER OR CONDOMINIUM OWNER** who resides within the Redevelopment Area.
- CATEGORY F**    **EDUCATOR OR COMMUNITY LEADER WORKING TO BENEFIT CHILDREN** who resides in the City of Las Vegas.
- CATEGORY G**    **WARD 1 COMMUNITY MEMBER** who resides in or whose business address is located in Ward 1 and/or is selected by the Ward 1 Councilperson.
- CATEGORY H**    **WARD 3 COMMUNITY MEMBER** who resides in or whose business address is located in Ward 3 and/or is selected by the Ward 3 Councilperson.
- CATEGORY I**    **WARD 5 COMMUNITY MEMBER** who resides in or whose business address is located in Ward 5 and/or is selected by the Ward 5 Councilperson.
