

**SUPPLEMENTAL INTERLOCAL CONTRACT NO. 3  
BUS TURNOUT PROJECT  
EASTERN AVENUE**

**THIS SUPPLEMENTAL INTERLOCAL CONTRACT NO. 3** is made and entered into this 8<sup>TH</sup> day of February 2024, by and between the City of Las Vegas, a municipal corporation, hereinafter referred to as “CITY” and the Regional Transportation Commission of Southern Nevada, hereinafter referred to as “RTC.” The CITY and RTC are collectively referred as the “PARTIES.”

**W I T N E S S E T H**

**WHEREAS**, the RTC approved Interlocal Contract 1010 dated May 24, 2018, and supplemental interlocal contracts dated February 10, 2022, and June 8, 2023, for Bus Turnout Project – Eastern Avenue, hereinafter referred to as “PROJECT;” and

**WHEREAS**, Nevada Revised Statutes (NRS) Chapter 277.180 authorizes any one or more public agencies to contract with any one or more other public agencies to perform any governmental services, activity or undertaking which any of the public agencies entering into the agreement is authorized by law to perform and refers to such as an interlocal contract; and

**WHEREAS**, the CITY agrees to conform to the current RTC Policies and Procedures, as amended and incorporated herein by reference; and

**WHEREAS**, the CITY wishes to increase total PROJECT funding; and

**NOW, THEREFORE**, in consideration of the covenants, conditions, agreements, and promises of the PARTIES hereto, the PARTIES agree to proceed as follows:

**SECTION II: PROJECT COSTS; Paragraphs 1 and 2 shall be revised to read as follows:**

1. The total cost for this contract shall not exceed \$615,000.00.
2. Authorizations to Proceed (ATP) are granted as follows:
  - a. ENGINEERING not to exceed \$50,000.00
  - b. RIGHT-OF-WAY not to exceed \$158,000.00
  - c. CONSTRUCTION not to exceed \$407,000.00

The remainder of Interlocal Contract 1010 dated May 24, 2018, and supplemental interlocal contracts dated February 10, 2022, and June 8, 2023, shall remain unchanged.
