

Dear Mayor and City Council Members:

I sent correspondence to Councilwoman Allen-Penske (Ward 4) regarding my opposition to this project. I also completed the card I received and faxed that over. Admittedly, I may have presented more emotional objections (ie. Traffic, safety, noise/light, etc), so I figured I would reserve this correspondence to the facts with the hope that you will seriously consider not approving the project.

Facts (In no particular order):

- 1- The land (#1 & #2 map attached) is currently zoned as C-V. Civic District (ie. Schools, libraries, public parks, etc.)
- 2- There are no traffic lights at the intersection of Ann & Shaumber Rds.
- 3- A traffic study hasn't been prepared.
- 4- An economic value study showing impact to community (ie. population density, necessity, impact on property values) hasn't been prepared.
- 5- There are 75+ commercial activations within 5 minutes north on 215 (Hualapai exit) of the Ann Rd. exit.
- 6- There are 30+ commercial activations within 5 minutes south (Cheyenne exit) of the Ann Rd. exit.
- 7- The planning commission's own staff recommended denial of all requested variances and zoning changes except 1 (VAC1 - BLM easement).
- 8- The Applicant spent \$1.8 million on 5 acres (#1 & #2 on map attached) knowing it wasn't zoned for their intended use and when arguably a more suitable location (#3 on map attached) was available.
- 9- There was no outreach by the applicant to the neighborhoods who will be impacted by this project to get their feedback, either prior or post purchase of land.
- 10- And finally, and maybe most importantly, the applicant hasn't presented any arguments or facts as to why the zoning should be changed to allow his commercial project to be placed in our neighborhood's "back yard". Other than the implication that they want to profit from changing the zoning, which is more self-interest than a valid reason.

I know your task balancing the economic and growth needs of the City with the impact on quality of life is not an easy one. I would hope when you are reviewing projects like this one, you are also giving consideration as to whether there is a better location to accomplish the goals of the city and developers.


