DESCRIPTION

A PORTION OF GRAND PARK BOULEVARD PUBLIC STREET DEDICATED PER BOOK 166, PAGE 79 OF PLATS ON FILE AT THE CLARK COUNTY NEVADA RECORDER'S OFFICE, LYING WITHIN THE SOUTHWEST QUARTER (SW 1/4) OF SECTION 22, TOWNSHIP 20 SOUTH, RANGE 59 EAST, M.D.M., CITY OF LAS VEGAS, CLARK COUNTY, NEVADA, DESCRIBED AS FOLLOWS:

COMMENCING AT THE CENTERLINE INTERSECTION OF SANDSTONE RISE DRIVE AND GRAND PARK BOULEVARD AS SHOWN ON SAID PLAT; THENCE ALONG THE CENTERLINE OF SAID GRAND PARK BOULEVARD THE FOLLOWING TWO (2) COURSES: 1) NORTH 26°08'56" EAST, 540.72 FEET TO THE BEGINNING OF A CURVE, CONCAVE TO THE SOUTHEAST, HAVING A RADIUS OF 664.50 FEET; 2) NORTHEASTERLY ALONG SAID CURVE, THROUGH A CENTRAL ANGLE OF 15°08'01", AN ARC LENGTH OF 175.52 FEET; THENCE DEPARTING SAID CENTERLINE, SOUTH 48°43'03" EAST, 6.83 FEET TO THE SOUTHEASTERLY LINE OF COMMON LOT 61 AS SHOWN ON SAID PLAT AND THE BEGINNING OF A NON-TANGENT CURVE, CONCAVE TO THE NORTHWEST, HAVING A RADIUS OF 300.00 FEET, FROM WHICH BEGINNING THE RADIUS BEARS NORTH 48°43'03" WEST, ALSO BEING THE **POINT OF BEGINNING**; THENCE ALONG SAID SOUTHEASTERLY LINE THE FOLLOWING FOUR (4) COURSES; 1) NORTHEASTERLY ALONG SAID CURVE, THROUGH CENTRAL ANGLE OF 06°45'37", A ARC LENGTH OF 35.40 FEET TO THE BEGINNING OF A REVERSE CURVE, CONCAVE TO THE SOUTHEAST, HAVING A RADIUS OF 300.00 FEET, THROUGH WHICH A RADIAL LINE BEARS SOUTH 55°28'40" EAST; 2) NORTHEASTERLY ALONG SAID CURVE, THROUGH A CENTRAL ANGLE OF 17°48'18", AN ARC LENGTH OF 93.23 FEET TO THE BEGINNING OF A COMPOUND CURVE, CONCAVE TO THE SOUTHEAST, HAVING A RADIUS OF 668.67 FEET, FROM WHICH BEGINNING THE RADIUS BEARS SOUTH 37°40'22" EAST; 3) NORTHEASTERLY ALONG SAID CURVE, THROUGH A CENTRAL ANGLE OF 04°23'17", AN ARC LENGTH OF 51.21 FEET; 4) NORTH 56°42'55" EAST, 42.62 FEET TO THE BEGINNING OF A NON-TANGENT CURVE, CONCAVE TO THE SOUTH, HAVING A RADIUS OF 75.00 FEET, FROM WHICH BEGINNING THE RADIUS BEARS SOUTH 05°28'44" EAST; THENCE DEPARTING SAID SOUTHEASTERLY LINE AND EASTERLY ALONG SAID CURVE, THROUGH A CENTRAL ANGLE OF 02°39'08", AN ARC LENGTH OF 3.47 FEET TO THE BEGINNING OF A COMPOUND CURVE, CONCAVE TO THE WEST, HAVING A RADIUS OF 5.00 FEET, FROM WHICH BEGINNING THE RADIUS BEARS SOUTH 02°49'36" EAST; THENCE SOUTHERLY ALONG SAID CURVE, THROUGH A CENTRAL ANGLE OF 149°32'31", AN ARC LENGTH OF 13.05 FEET; THENCE SOUTH 56°42'55" WEST, 43.12 FEET TO THE BEGINNING OF A CURVE, CONCAVE TO THE SOUTHEAST, HAVING A RADIUS OF 657.67 FEET; THENCE SOUTHWESTERLY ALONG SAID CURVE, THROUGH A CENTRAL ANGLE OF 15°25'58", AN ARC LENGTH OF 177.15 FEET TO THE **POINT OF BEGINNING**.






