CONTRACT DESCRIPTION: Flamingo Boulder Hwy North, Charleston-Maryland to Boulder Hwy and Maryland Parkway System (Charleston/Maryland Storm Drain)

LOCATION: Within Charleston Blvd from Fremont to Maryland Pkwy. In Maryland Pkwy from Charleston Blvd to Stewart Ave. In 13th St from Charleston Blvd to Lewis Ave.

SCOPE OF WORK: Construction of a Regional Flood Control District RCB, laterals, drop inlets, relocations, and abandonments of CLV sanitary sewer, installation of LVVWD large and small diameter waterlines and appurtenances, pavement reconstruction, and ADA curb ramp upgrades. Work also includes concrete sidewalk, curb and gutter, fiber optic installation, trench dewatering, NDEP compliance, striping, traffic signal component replacements, ACP water and gas line abandonments, sewer bypass pumping, utility coordination, private parcel restoration, and all appurtenant improvements.

DESCRIPTION AND REASON FOR MODIFICATION: Due to the complexity of construction of the underground storm drain within the project limits, multiple conflicts have created a need for additional funding.
