23-0443-GPA1 - I oppose. This request would give developers unchecked permission to build out this land. An apartment complex can be developed without this approval, in a sustainable way, one that protects current residents. Unchecked density would only cause harm to the surrounding neighborhoods and already overburdened infrastructure. The developer can further develop this land without a change to TOC. Only the developer/property owner would benefit from approving. Not nearby residents, not even the city.
