RESOLUTION BY THE CITY COUNCIL EXTENDING THE DURATION OF TEMPORARY PROGRAMS ALLOWING CERTAIN TYPES OF BUSINESSES WITH AN ALCOHOLIC BEVERAGE LICENSE AND A RESTAURANT LICENSE TO OFFER AND PROVIDE THE DELIVERY, CURBSIDE PICK-UP, OR TAKE-OUT OF ALCOHOLIC BEVERAGES IN CONNECTION WITH THE DELIVERY, PICK-UP, OR TAKE-OUT OF FOOD BY A CUSTOMER WHO HAS PLACED AN ORDER THEREFOR

WHEREAS, previous and current conditions related to the COVID-19 virus have resulted in a number of negative impacts on businesses and individuals; and

WHEREAS, in an effort to provide affected businesses and individuals some relief from these negative impacts, the City Council previously approved Ordinance No. 6736 and authorized actions by the City Manager regarding various temporary programs and measures, including temporary programs allowing alcohol delivery and curbside or take-out alcohol in connection with meals; and

WHEREAS, the temporary programs and measures described below would otherwise terminate on January 1, 2021; and

WHEREAS, the City Council desires to extend the duration of the temporary programs and measures listed below to provide additional relief to affected businesses and individuals.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LAS VEGAS to extend the duration of the temporary program and measures described below until July 1, 2021, the cessation of the City's Declaration of Emergency, or the adoption of an ordinance codifying the measure or programs—whichever occurs earliest.
