I oppose this request. No new residential housing should be developed in that area. The land should remain as an open undeveloped land. It will take away the beautiful nature surroundings and impact the wildlife. More housing will impact existing residential areas with more traffic and increase the already crowded school class rooms. We have an ongoing teacher shortage. There are way too many housing developments in construction nearby and surrounding areas and we do not need more that might not be sold/populated. There is also a concern of another housing crash. There are homes that are in foreclosure due to the effects of the pandemic which would increase the availability of houses for sale. Another concern is the continuing water shortage. Lake Mead has about 8 years of water supply before it reaches the critical water shortage phase.

All new developments in this area should not be approved.
