

**SUPPLEMENTAL INTERLOCAL CONTRACT NO. 1  
CHARLESTON BOULEVARD  
TORREY PINES DRIVE, LAKE MEAD BOULEVARD, AND JONES BOULEVARD  
INTERSECTIONS IMPROVEMENTS**

**THIS SUPPLEMENTAL INTERLOCAL CONTRACT NO. 1** is made and entered into this 9<sup>TH</sup> day of June 2022, by and between the City of Las Vegas, a municipal corporation, hereinafter referred to as “CITY” and the Regional Transportation Commission of Southern Nevada, hereinafter referred to as “RTC.” The CITY and RTC are collectively referred as the “PARTIES.”

**W I T N E S S E T H**

**WHEREAS**, the RTC approved Interlocal Contract 1002 dated March 3, 2018, for improvements to Charleston Boulevard at Torrey Pines Drive, Lake Mead Boulevard, and Jones Boulevard Intersections Improvements, hereinafter referred to as “PROJECT,” located wholly within City of Las Vegas; and

**WHEREAS**, Nevada Revised Statutes (NRS) Chapter 277.180 authorizes any one or more public agencies to contract with any one or more other public agencies to perform any governmental services, activity or undertaking which any of the public agencies entering into the agreement is authorized by law to perform and refers to such as an interlocal contract; and

**WHEREAS**, the CITY agrees to conform to the current RTC Policies and Procedures, as amended and incorporated herein by reference; and

**WHEREAS**, the RTC wishes to change the funding account for the PROJECT; and

**NOW, THEREFORE**, in consideration of the covenants, conditions, agreements, and promises of the PARTIES hereto, the PARTIES agree to proceed as follows:

**SECTION II: PROJECT COSTS; the first sentence shall be revised and Paragraph 5 shall be added to read as follows:**

The RTC agrees to provide funding for all costs associated with the PROJECT from the Highway Improvement Acquisition Fund.

5. The RTC agrees to reimburse funds advanced by the CITY for eligible PROJECT costs incurred after February 10, 2022.

The remainder of Interlocal Contract #1002 dated March 3, 2018, shall remain unchanged.
