**ORDINANCE NO. \_\_\_\_\_**

AN ORDINANCE TO AMEND LVMC TITLE 10 TO ADD A NEW CHAPTER ESTABLISHING A CURFEW APPLICABLE TO PERSONS UNDER THE AGE OF TWENTY-ONE AND PERTAINING TO THE AREA BOUNDED BY OGDEN AVENUE ON THE NORTH, 8TH STREET ON THE EAST, CARSON AVENUE ON THE SOUTH, AND MAIN STREET ON THE WEST; AND TO PROVIDE FOR OTHER RELATED MATTERS.

Summary: Amends LVMC Title 10 to add a new chapter establishing a curfew applicable to persons under the age of twenty-one and pertaining to the area bounded by Ogden Avenue on the north, 8th Street on the east, Carson Avenue on the south, and Main Street on the west.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title 10 of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended by adding thereto a new chapter, designated as Chapter 94 and consisting of Section 10 thereof, reading as follows:

**10.94.010:** (A) Notwithstanding and independent of any provision of LVMC Chapter 10.54, and except as otherwise provided in Subsection (C), it is unlawful for any person under the age of twenty-one years to be in or upon any public street, public sidewalk or any parking lot, driveway or walkway open to the public within the area described in Subsection (B) on any day of the week between the hours of nine p.m. and five a.m. the following day.

(B) The area to which Subsection (A) applies is the area bounded by Ogden Avenue on the north, 8th Street on the east, Carson Avenue on the south, and Main Street on the west.

(C) The prohibition described in Subsections (A) and (B) does not apply to:

(1) Any special event permitted pursuant to the provisions of LVMC Chapter 12.02, provided that the special event permit specifically indicates that the prohibitions of this Section do not apply to such special event;

(2) A person under the age of eighteen years if accompanied by the person's

1 parent or legal guardian;

2 (3) A person who is engaged or in the course of the person's employment, or  
3 who is going to or from the place of such employment during the period from one-half hour before to one-  
4 half hour after work. To qualify for this exception, the person must be carrying a written statement from the  
5 employer attesting to the place and hours of employment; or

6 (4) A person engaged in interstate travel or whose presence in the area is the  
7 result of an emergency.

8 SECTION 2: If any section, subsection, subdivision, paragraph, sentence, clause or phrase  
9 in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid or ineffective by  
10 any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the  
11 remaining portions of this ordinance or any part thereof. The City Council of the City of Las Vegas hereby  
12 declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase  
13 thereof irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs,  
14 sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.

15 SECTION 3: Whenever in this ordinance any act is prohibited or is made or declared to  
16 be unlawful or an offense or a misdemeanor, or whenever in this ordinance the doing of any act is required  
17 or the failure to do any act is made or declared to be unlawful or an offense or a misdemeanor, the doing of  
18 such prohibited act or the failure to do any such required act shall constitute a misdemeanor and upon  
19 conviction thereof, shall be punished by a fine of not more than \$1,000.00 or by imprisonment for a term of  
20 not more than six months, or by any combination of such fine and imprisonment. Any day of any violation  
21 of this ordinance shall constitute a separate offense.
