My name is Maggie Bray and I own a private non-profit elementary school (Innovation Academy) in the NW part of Las Vegas. My school serves children in Clark County who would otherwise not be able to attend school in a traditional school setting (severe food allergies and specific academic needs, etc). My school is a neighbor to **five other schools** who reside within a couple miles of hundreds of school aged children.

Dotty's Tavern was approved by the LV City planning commission to build next to Innovation Academy in an adjacent area that is 444-feet away (from the Nevada Gaming Commission mandated 1,500-feet) from my school and a preschool. The decision to build this, places my education license with the State Department of Education at risk of being revoked - a fact I shared with the planning commission. The safety of our children is at risk.

Other key education leaders and I have gathered 583 signatures opposing the building of a bar and casino... 444-feet from my school, this community's school and other nearby schools. Children will pass by Dotty's as they walk to Neil Elementary school and other school facilities, TWICE a day.

A woman was robbed then murdered in a Dotty's Tavern parking lot. Her death is a warning that we, as neighbors, are obligated to listen to.

Dotty's was granted approval to build next door to my business, a preschool and more. We have fought so very hard to oppose this. Thousands of kids and families will be affected by this decision and their safety is at risk. We fought at the planning commission meeting and lost. We are to preserve the quality of life that our kids have enjoyed for many years and not invite more crime into our lives with needless taverns and bars.

City Commissions that voted in favor of the building of Dotty's said "Dotty's is a mild casino" and also Jay Brown the attorney of Dotty's stated "the number one selling drink sold at Dottie's is water". I don't consider armed robbery and murder "mild".

This appeal is a formal request for the planning commissioners that voted to approve it on the basis of it being "safe" to reconsider and vote appropriately now that there is proof that it is not safe.

I'd bet the woman who was robbed and then murdered would disagree, if she could.
