RE: Bid No. 220179-MC Synthetic Turf Surfacing Replacement protest of award of contract to Sprinturf LLC submitted by Parker Nelson & Associates on behalf of CG&B Enterprises, Inc.

Dear Mr. Parker:

I have reviewed the bid protest documentation submitted on behalf of your client, CG&B Enterprises, Inc. The issue brought forth is in regards to the appropriate Nevada State Contractor's license required to do the work as described in the bid scope of work for project 220179-MC Synthetic Turf Surfacing Replacement.

As stated in your letter, Sprinturf LLC has a valid C-10 License. Per the Nevada Administrative Code (NAC) 624.280:

2. A person who holds a classification **C-10 license may grade and prepare plots of land for architectural horticulture**, decoratively treat, arrange, plant and maintain gardens, lawns, shrubs, vines, bushes, trees and other vegetation, construct systems of drainage and landscape irrigation, install rocks, sand, gravel and other landscape materials that use xeriscape principles, hydroseed by spraying mulch, seeds and nutrients under pressure, control soil erosion **and install nonengineered decorative landscape ponds or nonengineered prefabricated trellises and arbors.**

Andrew Bone of CG&B did contact Ms. Maira Corral to express his opinion that Sprinturf had an inadequate license. Maira contacted the Nevada State Contractors Board and confirmed that **installation and removal of artificial turf only requires a C-10 license** if the value of the contract is greater than \$1,000. An "A" License is not required.

Based on the above facts and in accordance with City of Las Vegas R-50-2017 (Resolution Adopting Procedures For The Protest Of An Award of Contract), I have determined that a C-10 license is sufficient to complete the scope of work included in Bid No. 220179-MC. Contract proceedings with Sprinturf LLC will recommence.
