700 Park Paseo 9/7/22 City Council Appeal

City Council granted appeal to applicants at 700 Park Paseo subject to the HPC conditions listed below:

- The hot tub shall be adequately screened from public view.
- The outdoor shower and surrounding privacy fence shall be designed and constructed with materials that are consistent and compatible with the exterior of the house.
- The design of the garage conversion must conform to John S. Park Design Guidelines. This includes (1) all
 material must be compatible with the exterior of the house, (2) the shape and form of the roof may not be
 altered, and (3) any new windows must match all other windows currently on the house.
- The wooden fence along the north property line shall be reduced to 5-feet in height to allow for an unobstructed view of the house so that it contributes to the historic character of the neighborhood. In addition, the entirely of the fence should be of consistent matching materials rather than an abrupt change from iron and masonry piers to wood.
- Adherence to all Historic Preservation Commission's conditions of approval related to the Certificate of Appropriateness associated with 22-0327-HPC unless modified herein.
