## **CERTIFICATE - DISCLOSURE OF OWNERSHIP/PRINCIPALS**

"City" means the City of Las Vegas.

"City Council" means the governing body of the City of Las Vegas.

### 2. Policy

Such disclosure generally is required in conjunction with a Request for Proposals (RFP). In other cases, such disclosure must be made prior to the execution of a contract.

Upon execution of such contract, the Contracting Entity is under a continuing obligation to notify the City in writing of any material changes to the information in this Certificate. This notification shall be made within fifteen (15) days of the change. Failure to notify the City of any material change may result, at the option of the City, in a default termination (in whole or in part) of the contract, and/or a withholding of payments due the Contracting Entity.
