(Amended per Bill 2001-70, Ordinance 5346, adopted 8-1-2001, to indicate financial disclosure requirement)</p> <p>(Amended per Bill 2001-145, Ordinance 5409 - First Amendment, adopted 1-2-2002, to increase compensation for members from \$50.00 to \$80.00 per meeting attended, effective October 1, 2001 per SB554)</p>			
<b>TERM:</b>	<p>4 years (Ord. 6159 8/17/2011 - limited terms to 3 full terms but cumulatively not to exceed 12 years – excluding members who served partial terms prior to 8/1/2011) (LVMC 2.44.020; 1-19-2000 Ord. 5193, Revised the expiration of members' terms to run concurrent with the term of the elected official recommending their appointment, although members may complete the term in the event the recommending elected official vacates office)</p> <p>Must fill unexpired terms.</p>			
<b>COMPENSATION:</b>	\$80.00 per meeting attended			
<b>APPOINTED:</b>	<p>7 Members-each member of the City Council recommends one person for appointment to serve at the pleasure of the Council w/approval of Council. Terms are coterminous with the member making the recommendation (Appointees may not be members of the elected governing body - NRS 278.040)</p>			
<b>NOTES:</b>	<p><b>MUST BE CITY OF LAS VEGAS RESIDENT.</b></p> <p><b>Per Senate Bill 147, effective June 11, 2003, compensated boards meeting certain criteria are no longer required to file State Financial Disclosure Statements. This board meets that established criteria.</b></p>
