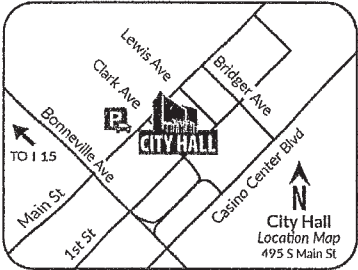

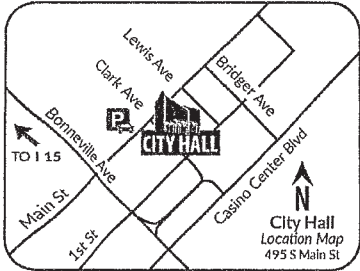

I oppose the permit for Value Market. The market at the corner of E. Sahara and Chapman Drive is a magnet for homeless and drug addicted patrons and drives a lot of unseemly foot traffic through the residential block, many of which have caused major disturbances. The vacant home immediately adjacent to the market, while I don't know who the actual owner is, seems suspiciously linked to this market. I've witnessed individuals coming from the market going straight to the adjacent property, which has been used as a drug or "trap" house. The home has had three fires in the ten months I've resided here from illicit drug use - check your

records. There's constant loitering, littering and homeless inhabiting. Homeowners have experienced squatters and repeated trespassing incidents from the very crowd that patronizes this market. I cannot prove there is a link between the two, but both are a pervasive problem for this neighborhood. As a new home owner, I am thoroughly disgusted with the lack of patrolling and police response time to incidents around here. This community does not need a liquor store anchor attracting and creating an unsafe environment.






