Hi Nancy,

I got your information from Karen Livingston at Save Floyd Lamb Park. I won't be able to attend the May 17th hearing but I wanted to share my support of the resolution (I included it after my thoughts). I am a volunteer for the Sierra Club.

I find #3 and #4 so important. Fireworks are not just a nuisance - noise pollution, plastic pollution, and air pollution. Not to mention the amount of emissions and waste produced throughout the supply chain of fireworks. I hope this makes it in the final resolution. As for the noise, completely agree. Parks are paid by taxpayers for taxpayers - not for large noisy capitalistic businesses that can afford holding their events elsewhere.

I really really hope you will stay true to these resolutions. You have my full support!

1. No special events after the historic hours of FLP (winter hours - 8 a.m. to 5 p.m. and summer hours - 8 a.m. to 8 p.m.), the one exception mentioned was the Boy Scouts Jamboree which is a weekend-long event.
2. The hay barn will be rented out to a maximum of 250 people and all events must end at 8 p.m.
3. No fireworks at FLP after 2023 (The City has already made arrangements to hold the 4th of July fireworks at FLP this year)
4. The city has agreed to purchase a decibel meter. They will be conducting tests at various decibel levels in the coming months to determine how loud an event at the hay barn can be before exceeding an acceptable level of noise to the homes closest to FLP. (Presently the Special Use Permit for the hay barn allows for 110 decibels, and this noise level is equivalent to shouting or barking in the ear and hearing loss is possible in less than 2 minutes.) The attached resolution says events at FLP will follow the City's noise code. However, Nancy has promised to change that once the reading of decibel levels is completed.
5. No competitive horse or animal events can be held at FLP (no rodeo or roping events)
6. Large company picnics can still be held at FLP (The IBEW picnic was mentioned as they apparently host a large number of people and rent out most of the park one day a year)
7. The following events will be allowed at FLP - fishing events, running events, weddings, celebration of life, filming project, senior center activities, fundraisers, baby showers, holiday celebrations, company picnics, service work projects, graduations, BBQs, field trips, volunteer appreciation events, class reunions, charity walks, car shows, and those activities that are considered passive recreation by the National Recreation and Parks Association.
