Proposal for VegasSmarter, Parks for People People for Parks, Support of Alternative Sentencing for Las Vegas Unhoused Population, Vegas SuperBowl SuperGoal End Homelessness 2023, Quality Living for All Movement, HomeLiftCare, HomeliftWish

Many would like the homeless to live invisible. Out of sight no problem. As is the way of nature, People need to experience nature, as in Urban Parks. People need bathrooms, housed or unhoused. People to have scheduled trash removal. When People are deprived of access to the great natural outdoors, they miss out of a vital connection with the universe.

Parks need to be preserved protected and respected as public spaces for all to share responsively. This means, parks should not places for the unhoused community to occupy.

While there is trash removal at the parks, those unhoused, without their own facility to bath, shower and maintain personal hygiene, who may carry bedbugs, lice, and other unhealthy germs present health risks to all by using park bathrooms and terrain as sleep and day long rest places. Often most or all park benches and tables are occupied and used by the unhoused. Many also bring their belongings of bags, papers and properties with them, occupying more space.

The unhoused are not an invisible population. It is predicted that there will be an increased, not a reduction, of the unhoused population as rent is increased and more evictions are inevitable. For Parks to be as they should be, shared spaces for all to enjoy nature, the unhoused need alternative spaces for their constant use, day and night. One courtyard is not the solution. The new buildings at courtyard are used for service providers not to house people. Investing instead in bathrooms, trash removal and a shuttle to transport those unhoused to resources, like courtyard to shower will likely prove to be the most beneficial to meeting the unhoused needs and restoring parks as public spaces all can enjoy with lesser health risks.

I propose of you Mayor and City Counsel to use the power of your office, position, title, funds, staff and resources to develop, plan, approve, plan and fund a Parks for People People for Parks Campaign, to gain business support, residents support, supporters, friends and sponsors to make parks public spaces. Currently in some zip codes most parks are made Children's Parks. This deprives the majority of the community access to parks. Only those 12 years and younger and their supervising adult can enter parks. This is wrong and unfair. We all need parks. Youth 13 and older will have no parks to go to throughout the summer. Seniors have on local parks to walk to. The General Adult and Teen population are deprived of parks that should be Public Parks use as many reasonable expect to them be as public spaces. Children under 12 without supervision could suffer some medical emergency, play and get hurt on playground equipment, stay in the play in the heat too long, be exposed and injured by unsafe objects, or get into conflicts and fights with no adults anywhere near. Signs posted do not stop some violator from entering the park and abusing a child alone in a Children's Park.

Besides the parks being zoned for special uses, businesses need what I propose as Business Zones. Many unhoused, likely most, if not all, will honor Business Zones, and stay 25 feet from businesses. Of course for Business Zones to work, the unhoused first need their own zones.

I propose zones throughout the city, perhaps every 3 miles, for the unhoused where they have bathrooms, scheduled rides to Courtyard and space they can rest or sleep. Service providers can bring them food water and resources. Posting can offer jobs and referrals to help.

I propose VegasSmarter, a citywide Campaign for all to contribute to make Las Vegas a model city for being humane. For caring and being responsible to solve problems. Things like using music and sound as a weapon to chase the unhoused away after they shop in a store must be made illegal, enforced not code enforcement not to allow. I propose to the DA an Alternative Sentencing for Las Vegas Unhoused Popluation. Instead of criminal charges, fines and jail time for trespassing or other violations civil charges are made. The guilty sentenced to housing, where there will be resources to help them overcome addictions or get proper care. Many of the unhoused are said to suffer mental challenges or have addictions. Living unclean in unhealthy ways is evidence of people needing help not inhumane prosecution. No person is human waste. Not even racists. Racists are not invisible. Their footprints are throughout America Culture, Traditions, Systems and Laws. Racists minds need to change to end the persisting injustice and unfairness that results from their denial of fact and truth that people are people not pollution pests or things to oppress suppress enslave and misuse. I am founder of three movements, Quality Living for All, HomeliftCare and HomeliftWish. I urge all of you to be leaders of these movements. I urge all to own them. We all need to do our best to ensure quality living for all. Sharing parks is part of enjoying quality of life in nature. HomeLiftCare is instead of stigmatizing the homeless, let's all care to meet their needs and provide the essential resources they need to stay clean and healthy, sleep and have bathrooms, although unhoused. HomeLiftWish is for leaders, businesses and residents everywhere to hear the unhoused. They speak loud with their trail of trash. They shout at us, with the odor of using sidewalks alleys and buildings as urinals and bathrooms. The unhoused are citizens. This is 2023. 2024 for Las Vegas is the Superbowl. Making 2023 the year to resolve the concerns many share of the unhoused problems within our communities and on residential and business properties. I propose a super goal of ending homelessness, at least for the day of the Superbowl, in Las Vegas.
