WHEREAS; VEGAS JUSTICE LEAGUE IS A SUBSIDIARY OF THE NON-PROFIT ORGANIZATION *VEGAS HELPS*, AND IS COMPRISED OF PHILANTHROPISTS WHO MAKE CONTRIBUTIONS AND ARE DEDICATED TO SOLVING COLD CASES IN SOUTHERN NEVADA; AND

WHEREAS; VEGAS JUSTICE LEAGUE SUPPORTS AND EMPOWERS THE CITY OF LAS VEGAS AND THE LAS VEGAS METROPOLITAN POLICE DEPARTMENT (LVMPD) BY ASSISTING IN SOLVING CRIMES COMMITTED LOCALLY; AND

WHEREAS; VEGAS JUSTICE LEAGUE MEMBERS PROVIDE MONETARY DONATIONS TO FUND LVMPD COLD CASES BY SUBMITTING DNA FOR REEVALUATION THUS UTILIZING THE NEWEST TECHNOLOGIES PREVIOUSLY UNAVAILABLE AT THE TIMES THE CRIMES WERE COMMITTED; AND

WHEREAS; VEGAS JUSTICE LEAGUE SOLVED ITS FIRST COLD CASE, WHICH ALSO SET THE WORLD RECORD FOR THE SMALLEST SAMPLE OF DNA USED TO SOLVE A CASE WITH JUST 15 HUMAN CELLS ON JULY 21, 2021; AND NOW

THEREFORE; I, THE MAYOR OF THE CITY OF LAS VEGAS, COUNTY OF CLARK, STATE OF NEVADA, HEREBY PROUDLY PROCLAIM JULY 21, 2023, AS:
