Minutes:

CITY MANAGER MIKE JANSSEN introduced the item, explaining that an interest list for the Department 5 Municipal Court Judge vacancy was formed per the Council's direction at the February 7th meeting.

VINCE ZAMORA, Human Resources Director, reported that the job was solicited on the websites for the City, Nevada State and Clark County Bar Associations, and the UNLV (University of Nevada, Las Vegas) Boyd School of Law for seven days. Of the three individuals that expressed interest, PETER CLEARY and MARK ROUSE, met the minimum requirements, which are outlined on the Agenda Summary Page attached to this item. After consideration, the Municipal Court judges and administration recommended MR. CLEARY for appointment.

COUNCILMAN KNUDSEN invited MR. CLEARY to the podium, who subsequently confirmed that he meets the minimum requirements as stated by MR. ZAMORA and understands the appointment is temporary. Subsequent to his motion, the Councilman acknowledged the competitive process and thanked MR. CLEARY for applying. The Mayor thanked CEDRIC KERNS for his service.

**PURPOSE/BACKGROUND:**

Department 5 Municipal Court Judge Cedric Kerns has submitted his resignation effective March 4, 2024. In accordance with the Las Vegas City Charter 1.160, a vacancy in the office of Mayor, Council Member or Municipal Judge must be filled by the majority vote of the entire City Council within 30 days after the occurrence of that vacancy. The interim judge must meet the following criteria:

1. Must devote full time to the interim position
2. Be a duly licensed member of the State Bar of Nevada in good standing, and have other such requirements as prescribed by any ordinance and City Charter
3. Be a resident of the City of Las Vegas
4. Not currently subject to disciplinary action by the State Bar of Nevada or any other court or tribunal
5. Not have been previously removed or retired from Judicial Office by the Commission on Judicial Discipline

The candidate selected will acknowledge, prior to appointment by the City Council, on the public record, that they understand the appointment is temporary and with the understanding that the candidate selected will not run for the office in the 2024 Municipal Election.

**RECOMMENDATION:**

Appointment of a qualified individual to fill the seat of Municipal Court Judge Department 5 as a caretaker until a permanent judge is elected in the 2024 Municipal Election.

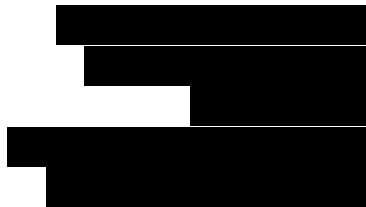

To Whom It May Concern,

My name is Mark Rouse, and I am applying for the Interim Municipal Court Judge (Department 5) – Interest List. I have been a resident of Las Vegas since 2010, and a practicing attorney in our community since 2011. I know that I have the legal knowledge, experience, and training to be an asset for the Municipal Court.

I realize that this position is on an interim basis and that I am not eligible to run for this open seat. I also acknowledge that the duration of this position may fluctuate depending on the results of the June primary. I have also applied for the open hearing commissioner position, and it is my understanding that in the past hearing commissioner(s) have been utilized to serve as interim municipal court judges.

I've been interested in serving the Las Vegas community as a judicial officer since I first moved to Las Vegas. I moved to Las Vegas to work on judicial campaigns and was fortunate to serve as the first law clerk for the Hon. Nancy Alf (ret.), Eighth Judicial District Court, Department 27, starting in 2011. As a law clerk to a new judicial department, I felt a sense of responsibility to establish a precedent to help the department run as smoothly and efficiently after my service ended. I developed bench briefs for motion hearings the court had twice a week, reviewed and revised incoming orders and drafted proposed orders for matters taken under advisement. I found this position challenging as Dept. 27 was a civil only department, at the time, and I focused my law school career on criminal law. I rose to the challenge of working in a civil only department and devoted myself to learning the Nevada Rules of Civil Procedure and Eighth Judicial District Court Local Rules. During my clerkship, I also took three bar exams, becoming a licensed attorney in California, Kentucky, and Nevada.

Since my clerkship, I've devoted my legal career to becoming a successful trial attorney. In my first year of practice, I tried three civil jury trials to a verdict. Two of the cases were for personal injuries, and the third was an insurance defense case, which I first chaired. Subsequently, I've tried three civil short trials on my own, first chaired two civil bench trials, second chaired two personal injury civil jury trials, and second chaired one medical malpractice civil jury trial.

Last year, 2023, was my most successful trial year. I obtained a \$100,000 judgment against the Clark County School District in May in a bench trial for negligent supervision, where my clients previously lost at court mandated arbitration. Approx. two weeks after that trial, I had a motor vehicle collision case where I performed the direct examination of all treating physicians and medical experts, the plaintiff, and some before and after witnesses. We obtained a verdict of approx. \$2.5 million. My last trial of 2023 was in the fall and involved a wrongful death medical malpractice case. I performed the direct examination of all medical experts, cross examined the only defense expert, directed the plaintiff and most before and after witnesses. I also did the punitive damages phase of the trial on my own, cross examined the only witness, made the closing argument and

rebuttal. We obtained a verdict of approx., \$10.9 million, with \$2 million in punitive damages.

After last year, you may be wondering why I would apply for an interim judicial position such as this. The answer is cliché but also straightforward. I'd like to be a judge to serve the community. The interim position is unique in that it gives me the opportunity to have a preview or trial run, of the duties, responsibilities and expectations that serving as an elected judge would entail.

I have a breadth of legal experience having practiced in the areas of criminal defense, prosecution, judicial law clerk, social security disability, insurance defense, commercial litigation, appeals, legal malpractice, employer defense, personal injury, and medical malpractice during my legal career. I am a student of the law, and constantly striving to improve my skills. Approx. two years ago I had only handled one medical malpractice case and now those are most of the cases I litigate. Much like my clerkship when I had never worked in civil law and transitioned from criminal law, I have found in my career that I thrive in challenging myself to develop new skills. I believe I have the right temperament, work ethic, and integrity to serve the city well during this interim period.
