WHEREAS, MAYOR CAROLYN GOODMAN AND MEMBERS OF THE LAS VEGAS CITY COUNCIL RECOGNIZE PERRY ROGERS, CEO AND FOUNDER OF PRP COMPANY; AND

WHEREAS, PERRY ROGERS IS A NATIVE OF LAS VEGAS. HE IS THE HUSBAND TO NICOLE AND FATHER TO HANNAH, GRANT, AND RYAN; AND

WHEREAS, PERRY ROGERS GRADUATED FROM GEORGETOWN UNIVERSITY WHERE HE RECEIVED A BACHELOR'S DEGREE IN ACCOUNTING IN 1991, AND THE UNIVERSITY OF ARIZONA WHERE HE EARNED HIS LAW DEGREE IN 1994; AND

WHEREAS, PERRY ROGERS WAS THE PRESIDENT AND FOUNDER OF AGASSI ENTERPRISE AND FOUNDATION, A NOT-FOR-PROFIT PRIVATE CHARITY DEDICATED TO PROVIDING EDUCATIONAL OPPORTUNITES AND RESOURCES TO OTHERWISE UNDERSERVED POPULATIONS. ANDRE AGASSI COLLEGE PREPARATORY ACADEMY OPENED IN THE HISTORIC WESTSIDE IN 2001 WITH THE PHILOSOPHY THAT EVERY CHILD DESERVES AN OUTSTANDING EDUCATION, AND CHILDREN THRIVE IN AN ENVIRONMENT WHERE EXPECTATIONS ARE HIGH AND EXCELLENCE IS THE STANDARD TO BE EMBRACED; AND

WHEREAS, PRP IS A SPORTS MANAGEMENT AND BRAND-BUILDING COMPANY WITH A CLIENT ROSTER REPRESENTING ATHLETES SUCH AS NBA HALL-OF-FAMER SHAQUILLE O'NEAL, THE BOSTON CELTICS' ALL-STAR MVP JAYSON TATUM, AND WNBA ATLANTA DREAM PLAYER HALEY JONES TO NAME A FEW; AND

WHEREAS, PERRY ROGERS HAS A 25-PLUS-YEAR CAREER OF REPRESENTING ATHLETES. HE ALIGNS HIS CLIENTS WITH BRANDS SUCH AS NIKE, AIR JORDAN, REEBOK, AMERICAN EXPRESS, BURBERRY, CANON, LONGINES, BUICK, ADIDAS, SOFI, CARNIVAL CRUISE LINE, RING, EPSON, TURNER SPORTS AND MORE TO CREATE POWERFUL MESSAGING AND MEMORABLE ADS; AND

WHEREAS, PERRY ROGERS IS ON THE BOARD OF DIRECTORS FOR THE SHAQUILLE O'NEAL FOUNDATION. THROUGH ITS "COMBAQ COURTS" PROGRAM WHICH REFURBISHES EXISTING PUBLIC BASKETBALL COURTS THROUGHOUT THE COUNTRY. THE BASKETBALL COURTS AT THE DOOLITTLE COMPLEX RECEIVED A \$200,000 DONATION IN PARTNERSHIP WITH ICY HOT, AND THE MAYOR'S FUND FOR LAS VEGAS LIFE. THE FOUNDATION ALSO RECENTLY BROKE GROUND TO BUILD A BOYS & GIRLS CLUB IN EAST LAS VEGAS; AND

WHEREAS, PERRY ROGERS IS A MEMBER OF THE BOARD OF TRUSTEES FOR THE UNIVERSITY OF NEVADA, LAS VEGAS FOUNDATION, BOARD OF DIRECTORS LEXICON BANK. HE PREVIOUSLY SERVED ON THE BOARDS FOR THE ATP TOUR, SIX FLAGS INC., NEVADA FIRST BANK, MEADOWS BANK, BOYS AND GIRLS CLUBS OF LAS VEGAS TO NAME A FEW; AND

WHEREAS, WE RECOGNIZE THE OUTSTANDING CAREER AND PHILANTHROPIC EFFORTS SHOWN BY PERRY ROGER OVER DECADES TO SUPPORT NUMEROUS NON-PROFITS. HE GRACIOUSLY RETURNED HOME TO LAS VEGAS FOLLOWING COLLEGE TO MAKE A DIFFERENCE IN SERVING AND IMPROVING THE LIVES OF PEOPLE IN THE CITY WHERE HE WAS BORN AND RAISED. HIS SPIRIT OF COMMUNITY, GIVING, AND SERVICE TO RESIDENTS DESERVES THE HIGHEST ACCOLADES; AND NOW


